BE IT REMEMBERED that on the 14th day of March, A.D. 2016 the Commissioner Court of Howard County met in regular session at 5:30 PM with KATHYRN G. WISEMAN, County Judge as the Presiding Officer. The following members were present: OSCAR GARCIA, Commissioner Precinct No. 1, JIMMIE LONG, Commissioner Precinct No. 3 and JOHN H. CLINE, Commissioner Precinct No. 4. CRAIG BAILEY, Commissioner Precinct No. 2 was absent.

A motion was made by Commissioner Garcia and seconded by Commissioner Cline to accept the Annual Financial Report from Don Stephens, CPA. The audit was found to have no problems. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to table the Interlocal Agreement with the City of Big Spring on the Fiber Infrastructure. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Long to approve the following 5 Right of Ways as presented by Brian Klinksiek, County Engineer: 1 to OXY USA Inc. on Stallings Road; 2 to WTG Gas Processing on Moore School Rd and NCR 21 and 2 to H. H. Wilkinson's Cross F Ranch both on Russell Rd. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Brian Klinksiek, County Engineer presented another grant bill in the amount of \$114,786.73 and he also reported that the road work had begun in Precinct 3.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the request from CGG to do the seismic work on roads. They will put up a \$500,000 bond, they will repair any damage done to any county roads and they will work closely with County Engineer and compensate him for time worked on this project. A vote was taken and the following members of the Court unanimously voted "AYES": Commissioner Garcia, Commissioner Long and Judge Wiseman. Commissioner Long voted "NO". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Cline to allow Brian Klinksiek, County Engineer permission to start his Pilot Program to change hours that field crews will work to make the Road and Bridge Department more productive. Everyone will still work 40 hours per week and they will not change their office hours. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve the Department Head recommendations as presented by Teresa Thomas, County

Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Long and seconded by Commissioner Garcia to approve the payroll report as presented by Teresa Thomas, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Cline and seconded by Commissioner Garcia to approve the Treasurer's Monthly Report as presented by Teresa Thomas, County Treasurer. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Cline to approve the County Clerk Monthly Report as presented by Donna Wright, County Clerk. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
