He met with the jail commission on how he could add 12 beds to our facility on a temporary basis by asking for variances by December 5th. If this is asked for the Court has to have a plan to be adding on to the existing jail. The variance has to be requested every 6 mo. Sheriff asked the Court to think about this and let him know by the 27th meeting what they want him to do.

Their portion of the DPS Secretary salary is \$9524.11. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

A motion was made by Commissioner Garcia and seconded by Commissioner Long to approve the 2014/2015 Contract with Midland College for the Standard Breath Alcohol Testing Program @ \$12,540.00. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.

Stan Parker, Sheriff reported that Jail Standards were here in September and did a walk through and they passed with flying colors.

Chuck Rosenbaum, registered citizen addressed the Court about the property around his home that was overgrown and invested with rodents. It is ¹/₄ acre at the corner of Dogwood & Wasson Rd the area is covered with old cars, buses and weeds. They have and open septic tank. He is having a real issue with mice. Court informed him they really had no jurisdiction and referred to the City and he had already spoken with them. Court said he could get a petition and Mr. Rosenbaum said he owned all the property around this area besides this owner. Court then advised him to talk to Joshua Hamby, County Attorney.

Judge Barr welcomed Drew Lopez as the new County Auditor as of October 1, 2014.

A motion was made by Commissioner Cline and seconded by Commissioner Long to approve the fuel bid as was the only one from Parks Fuels as presented by Drew Lopez, County Auditor. A vote was taken and the members of the Court unanimously voted "AYES". Motion carried.
