approve West TX H2O to lay a permanent water line across the old airport property in the

pipeline corridor at the \$200 per joint price. Brian Klinksiek will get Josh Hamby, County

Attorney to look this over once he receives it. A vote was taken and the members of the Court

unanimously voted "AYES". Motion carried.

Court agreed to allow Brian Klinksiek, County Road Administrator to change the Dead

End Intersection Signage as he presented in Court.
