Meeting Called to Order at 10:01 AM.

Judge Johnson swore in re-elected officials, Eddilisa Ray, Commissioner Precinct No. 1, Lindsay Wilkerson, County Attorney and Tiffany Sayles, County Tax Assessor Collector. No Action Needed.
